#### **MINUTES**

## AMEND SUBDIVISION REQUIREMENTS; SCENIC VIEWSHED OVERLAY

CUC discussed the revised draft, which refers to the SASS regulations and contains a revised inventory of scenic features, and comments that were provided to M. Reisman; he will incorporate into the document. Also discussed was comparison to MU-1 district as it relates to the draft. It was recommended that this topic be included in Chapter 134-18 (applies to all districts).

### **STEEP SLOPE STANDARDS**

CUC discussed comments from Badey & Watson. It was agreed that the Badey & Watson comments would be incorporated into the Steep Slope Standards.

- References to "design professionals" should be made consistent within the document
- While the intent of this section is not to limit homeowner rights, some portions appear to limit them
- Is this a duplication of NYS code?
