### Board of Trustees Meeting Minutes - October 5, 2021

The Board of Trustees of the Village of Cold Spring held a workshop meeting on October 5, 2021 via videoconference as per Chapter 417 of NYS Laws of 2021. Present were Mayor Dave Merandy, Trustees Marie Early and Frances Murphy. Trustee Kathleen E. Foley arrived at 7:25pm. Trustee Tweeps Phillips Woods was absent. D. Merandy called the meeting to order at 6:30 pm.

#### **Continuation of Public Hearing for Chapter 126**

There were no additional public comments. D. Merandy made a motion to close the public hearing for Chapter 126 – Vehicle and Traffic. M. Early seconded the motion and it passed by a vote of 3-0-0-2 (K. Foley and T. Woods absent).

#### **Workshop with Recreation Commission**

The Recreation Commission presented drafts of new applications for Ticketed and Non-ticketed uses of Village Parks (Mayor's Park Field and/or Pavilion, McConville Park and Bandstand). Comments from the Board included:

- M. Early stated that allowing 2,000 people for ticketed events was too many for the village.
   After a brief discussion it was agreed to reduce the figure to 1,500 inclusive of vendors and organizer personnel.
- M. Early stated that a time limit should be instituted for the use of Mayor's Park Pavilion at the proposed fee levels. After a discussion it was agreed to set a 4-hour time limit with an additional charge of \$25/hour for each hour over 4 hours.
- Requirements for tent inspections by the Building Inspector should be added to the Terms & Conditions

The Recreation Commission will make the necessary edits to the applications and re-submit to the Board for review

- D. Merandy made a motion to accept Ruthanne Cullinan Barr's resignation from the Recreation Commission. M. Early seconded the motion and it passed by a vote of 3-0-0-2.
- D. Merandy made a motion to appoint Jeff Amato, Jr. as Chair of the Recreation Commission. F. Murphy seconded the motion and it passed by a vote of 3-0-0-2.
- D. Merandy made a motion to appoint Aaron Michaeal Leonard as a member of the recreation Commission. M. Early seconded the motion and it passed by a vote of 3-0-0-2.

**Resolution 70-2021** (attached) adopting Local Law 32 of 2021 repealing Chapter 101 – Shopping Carts from the Village Code was offered by D. Merandy for adoption and seconded by M. Early. Upon roll call vote, the resolution passed by a vote of 3-0-0-2.

**Resolution 71-2021** (attached) awarding the bid for the rebuilding of a stone wall to Jablko Construction was offered by D. Merandy for adoption and seconded by F. Murphy. Upon roll call vote, the resolution passed by a vote of 3-0-0-2.

Request by Chamber of Commerce for use of Bandstand and Halloween Parade: Tabled pending additional details from Chamber of Commerce regarding coordination of start of parade. F. Murphy to contact Chamber.

#### Request for relief from Chapter 100 - Short Term Rentals

Dave and Melia Marzullo, owners of 75 Main Street, appeared before the Board seeking relief from the Chapter 100 – Short Term Rentals - on the grounds of economic hardship. They are requesting a 1-year exemption from the entirety of the code.

- M. Early stated that the request should be for relief from a specific section of the code and not the entirety of it. She added that if granted, what would prevent everyone from applying for relief on the same grounds?
- D. Merandy agreed with M. Early's statements and added that if granted this could open to people buying "properties for profit" in the Village.
- K. Foley noted the request defeats one of the goals of the law LLC's with non-residency occupancy. She added that the property owners can still utilize the property for long-term rental
- D. Merandy stated that more time was needed to consider the request. The matter was tabled until further notice.

**Approval to purchase Toughbook:** D. Merandy made a motion to approve the quote of \$6,288.54 for the purchase of Toughbook for the new police car. K. Foley seconded the motion and it passed by a vote of 4-0-0-1.

Request by League of Women Voters to set up Voter Registration table on Main Street: D. Merandy made a motion to allow the League of Women Voters to set up a Voter Registration table on Main Street (adjacent to Visitor's Center) on 10/6 and/or 10/7. K. Foley seconded the motion and it passed by a vote of 4-0-0-1.

#### Discussion on chapter 134 – Zoning

M. Early presented revisions to the zoning classifications of specific properties based on discussion and vote of Board at the 9-29-2021 meeting (see attached spreadsheet).

### RESOLUTION #71-2021 AWARDING BID FOR REBUILDING STONE WALL

The following resolution was offered by Mayor Dave Merandy for adoption and seconded by Trustee Frances Murphy, to wit:

WHEREAS, the Village of Cold Spring (the "Village") needs to rebuild a portion of the stone wall located on the north side of Main Street between "B" and Orchard Streets; and

**WHEREAS,** the Village solicited bids via The Empire State Bid System and required Legal Notice in the Village's newspaper of record; and

WHEREAS, the Village received a total of eight (8) bids; and

**WHEREAS**, Donald MacDonald, Architect, reviewed the submissions of the three lowest bidders and has made a recommendation to the Village; therefore

**IT IS HEREBY RESOLVED** that the Village awards the bid for the rebuilding of the stone wall on the north side of Main Street between B and Orchard Streets to the lowest bidder, Jablko Construction, at a cost of Eighty-Seven Thousand Dollars (\$87,000) plus the cost of supplying any additional wall stone necessary at a cost of Two Thousand Five Hundred Dollars (\$2,500) per pallet.
