# Workshop Meeting 6/27/17

The Village of Cold Spring Board of Trustees held a workshop meeting at the Cold Spring Village Hall, 85 Main Street on Tuesday, June 27, 2017 at 7:30pm. Present were Mayor David Merandy and Trustees: Lynn Miller, Marie Early, Frances Murphy, and Steve Voloto.

#### Call to Order:

The meeting was called to order at 7:32pm.

#### **Old Business:**

Mayor Merandy gave a summary of the festivities that are confirmed to be taking place on July 4<sup>th</sup>. There will be fireworks at 9:00pm fired from a pontoon boat, performances from four bands at Dockside and the Band Stand, food & drink vendors, a raffle, and the bike decorating contest.

#### **New Business:**

Mayor Merandy made motion to approve the minutes for the 6/6/17 CSVB meeting. Trustee Murphy seconded. The motion passed 4 to 0, with Trustee Voloto abstaining due to his absence from that meeting.
