OLD BUSINESS

Wells Fargo (Tenant) and Constantine Serroukas (Owner/Landlord) 41 Chestnut Street, Tax Map #49.9-4-14. Replace wall and canopy light fixtures on building exterior and add new wall fixtures. Property is located in the Historic District. As per Ch. 64 of the Village code, a Certificate of Appropriateness (COA) from the HDRB is required. Site plan approval required from the Planning Board per 134-10(F)(4).

Alex Andrup (GMR Engineering) described the project and noted that, per the previous meeting:

He has met with the HDRB

During the discussion it was noted that:

- M. Francisco has met with the Cold Spring Code Enforcement Official (CEO) regarding the location of the northern property line. Based upon a site plan for the adjacent property the property line was established and it's consistent with the owner's site plan markup
- Property owner will need to certify the property boundary is as shown on the application documents
- Property owner is requested to submit a current survey of the property

- The light pole will be moved onto the owner's property (rather than straddling the property line as now indicated.) Applicant believes this will not present a significant impact to the design or illuminance levels.
- Minor modifications to the application documents were requested
- Per direction of M. Francisco applicant to review NYS statute requirement regarding interior vs. exterior lighting requirement and a possible impact upon the lighting design (which may lower the required levels of illumination)
- Lighting fixtures on the north façade to remain as designed
