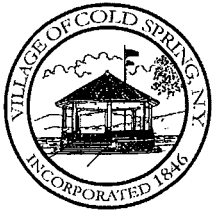

IT IS HEREBY RESOLVED that the Village awards the bid to Valley Tree Experts, LLC for maintenance pruning of twenty-eight (28) trees at a cost of Five Thousand Eight Hundred Forty Dollars (\$5,840).
