





## ENSURING OUR DRINKING WATER SUPPLY

- Cold Spring's water comes from a series of dams which collect water from natural sources, such as streams and rainfall flowing downhill to the Hudson River.
- A Village reservoir was first erected in 1895.
- The largest reservoirs near Lake Surprise, in the North Highlands, were build by the West Point Foundry in the 1860's and were bought by the Village in 1922.
- The existing Foundry Brook dams that collect and supply the village with water were built in 1934 and 1942.
- Our current Water Treatment Plant replaced an outdated plant in 1997.
- Three full-time staff, including licensed operators, keep both our water and sewer plants operational. They provide shift and on-call coverage 24 hours a day, 7 days a week.

## THE COST OF PROVIDING WATER IS RISING.

1. Plant electric bills, chemical costs, and state employee retirement pension expenses have risen dramatically this year.

2. Expanding regular maintenance and repairs will secure the water source but increases costs.

3. Deferred repairs to aging dams must be assessed, engineered and completed.




Adjusted for inflation, water rates in Cold Spring have not increased in the 26 years since the Water Treatment Plant opened, despite meeting the evolving regulatory requirements for clean water standards.

#### 2023-2024 REVENUE





## PROTECTING THE HUDSON RIVER

- Installation of the first sewer system began in 1904.
- Cold Spring's Wastewater Treatment Plant was built in the early 1970's. Before that, like most communities, Cold Spring dumped raw sewage into the Hudson River.
- In 2022, the plant removed 306,000 gallons of sludge from our wastewater.
- In 2022, the plant processed 72,662,000 gallons of wastewater, and released 72,356,000 gallons of treated water into the Hudson River.



#### THE COST OF WASTEWATER TREATMENT IS RISING.

1. Plant electric bills, sludge hauling costs, and state employee retirement pension expenses have risen.

2. Expanding regular maintenance, repairs and upgrades will protect natural waterways from sewage but adds a cost.

3. Aging equipment and an evolving regulatory environment means more upgrades and replacement of parts.

# **RISING SEWER RATES**



Adjusted for inflation, the sewer rates have increased moderately over time, because the Wastewater Treatment Plant is over fifty years old and requires continual maintenance. Evolving regulations and environmental protections also increases costs considerably.

#### ALL THREE TENTATIVE BUDGETS FUND MUCH-NEEDED IMPROVEMENTS AND ARE BALANCED WITH A MINIMAL TAX INCREASE THAT IS WITHIN THE NY STATE TAX CAP.

- DRINKING WATER. Reconnection to the Catskill Aqueduct and planning for vital dam repairs is finally under way.
- WASTEWATER TREATMENT. The budget deals effectively with skyrocketing operating costs.
- GENERAL FUND. The Village is shifting the burden off of village taxpayers to provide improved services and increased revenue with new measures such as parking permits, metered parking, STR regulation. In doing so, the Village will have better-equipped police officers, will continue village-wide repairs, and will increase access to professional expertise.
